Re: Targeted Employment Area Designation in Virginia

Dear Ms. Velarde:

The Virginia Employment Commission certifies that the following areas are Targeted Employment Areas (TEA) within the Commonwealth of Virginia. Targeted Employment Areas are defined as areas, which at the time of investment, are rural areas, or areas which have experienced unemployment of at least 150 percent of the national average rate within Virginia.

High unemployment areas were determined using the 2008 national not seasonally adjusted unemployment rate of 5.8 percent; 150 percent of 5.8 percent is 8.7 percent. High unemployment areas are any particular geographical or political subdivision located within a Metropolitan Statistical Area (MSA), or within a city or town having a population of 20,000, or more, within such state. Many of the high unemployment areas are tobacco-dependent regions, which are established under *Code of Virginia*. Section 3.1-1107, and defined as civil jurisdictions in Southwest and Southside Virginia, where they are historical tobacco production regions and are experiencing the highest unemployment rates within the Commonwealth of Virginia. In order to decrease the high unemployment rate while transforming into a less tobacco-dependent economy, these areas are designated as TEA to seek enhanced economic recovery and development.

Rural areas are defined as civil jurisdictions not located within any standard MSA as designated by the Office of Management and Budget, or within any city or town having a population of 20,000, or more, based on the most recent decennial census of the United States.
