# NOTICE ON THE STATE OFFICERS ELECTORAL BOARD MEETING

The first meeting of the State Officers Electoral Board (SOEB) will be at 10:30 am on January 20, 2016 in Room 2-025 (Second Floor in the JRTC), 100 W. Randolph, in Chicago. During this meeting, the cases will be called and appearances accepted (Objectors and candidates may appear in person themselves, or may be represented by counsel.) In addition, the SOEB will adopt the Rules of Procedure and appoint hearing officers to preside over each objection.

Following the initial meeting, the hearing officers will meet in Suite 14-100 with the parties assigned to them to conduct case management conferences to discuss brief and hearing scheduling, and other procedural matters. Evidence and argument will not be accepted at the initial meeting of the SBE or at the case management conferences following the meeting.

Candidates are STRONGLY encouraged to check the SBE website (<u>www.elections.il.gov</u>) to see if objections have been filed against them, and such candidates should appear at the SOEB meeting on January 20, 2016, even if the candidate's copy of the objection has not yet arrived by certified mail.
