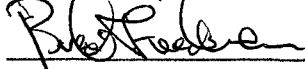
SIXTH: The corporation has no authority to issue capital stock.

Kimberlin

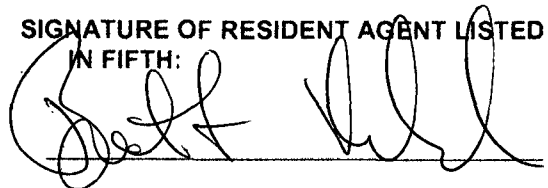
