TO COMPLY WITH FEDERAL LAW, WE MUST USE OUR BEST EFFORTS TO OBTAIN AND REPORT THE NAME, MAILING ADDRESS, OCCUPATION AND EMPLOYER OF ALL INDIVIDUALS WHOSE CONTRIBUTIONS AGGREGATE IN EXCESS OF \$200.00 PER ELECTION CYCLE.
