ORDER GRANTING SUMMARY FINAL JUDGMENT AND AWARD OF COSTS AND ATTORNEY'S FEES

THIS CAUSE came before the Court on Plaintiff's Motion for Summary Final Judgment and Award of Costs and Attorney's Fees. From the evidence the Court finds:

- On February 25, 2014, Plaintiff entered a final order against Defendant in case number FEC 10-368. Defendant has failed to comply with all of the terms of the Final Order.
- On August 8 2014, Plaintiff filed a Petition to Enforce Final Agency Action, and on September 27, 2014, Defendant was legally served a copy of the petition at the following address: 929 SW 15th Street, Deerfield Beach, FL 33441.
- 3. Plaintiff's current address is: 107 West Gaines Street, The Collins Building, Suite 224. Tallahassee, Florida 32399-1050
 - 4. On September 18, 2014, Defendant filed a response to the petition
- 5. On November 20, 2014, Plaintiff filed its Motion for Summary Final Judgment and Award of Costs and Attorney's Fees. Defendant failed to file a response
- 6. Based upon a review of Plaintiff's Motion for Summary Final Judgment and Award of Costs and Attorney's Fees, and the Court's file, this Court finds that there are no disputed issues of material fact, and Plaintiff is entitled to a judgment as a matter of law.
