AFFIDAVIT OF PROBABLE CAUSE

I, Affiant, Anthony Costello am a Detective with the Plymouth Township Police Department. Pursuant to my position I am assigned to investigate this incident of Domestic Assault.

On Saturday, February 15, 2014 at 1430 hours the Plymouth Township Police Department responded to 1423 Colwell Lane in the Conshohocken section, Plymouth Township, Montgomery County, Pennsylvania regarding a domestic assault. Upon arrival Officers spoke with the resident, Brad Craig and female victim Morgan Al-Rashid.

Brad Craig stated that just prior to contact the police Ibrahim Nasser Al-Rashid arrived at his home looking for his estranged wife Morgan Al-Rashid. Craig stated that Ibrahim was banging on his front door demanding to see Morgan. Craig stated that Ibrahim was accompanied by two other males. Craig stated he went outside to investigate and was detained by two males that had accompanied Ibrahim. Craig stated that one male held him and said "let him go inside and talk with her." Craig described the men as "intimidating". Craig complied and felt that he was not permitted back in his home while Ibrahim was inside with Morgan. Craig stated that approximately ten (10) minutes transpired and Ibrahim ran from the house and left the area with his associates in a dark colored SUV. Craig stated that he reenters his house and found Morgan Al-Rashid assaulted.

Morgan Al-Rashid stated that she and her estranged husband Ibrahim Nasser Al-Rashid are currently separated and going through divorce proceedings. Morgan stated that Ibrahim lives at 218 South Hibiscus Drive, Miami Beach, Florida 33139. Morgan stated that Ibrahim has made threats and assaulted her in the past but nothing as serious as this. Morgan stated that Ibrahim's behavior has been erratic for several months and she feels that it is because of excessive drug use. Morgan stated that this afternoon Ibrahim arrived at Brad Craig's home, forced his way in and assaulted her. Morgan stated that Ibrahim attempted to convince her to speak with him outside. Morgan stated that she resisted and was assaulted by Ibrahim. Morgan stated that Ibrahim grabbed her by the wrist, stuck her about the head and face with a closed fist then threw her to the ground. Morgan stated that there was no one else present during the assault but Officers on scene reported observing redness and swelling on Morgan's wrist and face consistent with her story. Morgan stated that after Ibrahim left the area he texted the following message "I am not sorry this time I hope you die in hell."

During the course of this investigation I had an opportunity to speak with Morgan Al-Rashid at the police station. I observed recent injuries that she described as being caused by Ibrahim Al-Rashid.

It was subsequently determined that Ibrahim Al-Rashid chartered an airplane from the Miami Beach area today and arrived at Ronson Aviation located at the Mercerville Airport, West Trenton, New Jersey. A representative of Ronson Aviation advised that the plane that Ibrahim chartered has left the area and is currently en route to the Miami Beach.

I contacted Ibrahim Al-Rashid by phone. He declined comment.


