(AMOT) Incident Narrative

On November 1st, 2018, I was dispatched to patrol to [REDACTED] for a report of a larceny complaint. It was reported that campaign signs were stolen from the callers front yard.

I arrived on the scene and was greeted by the caller, [REDACTED] who stated a Molinaro and Faso campaign signs were stolen from the front yard and he had the subject on security footage. As I was asked to step into the residence by [REDACTED], I observed a large TV in the living room displaying video footage of [REDACTED].

female exit a red Toyota Tacoma bearing New York registration #GPL8761. The female who fits the description of the registered owner gets out of the drivers seat and walks up to both signs and takes them from the yard. The female is then observed putting the signs in the rear of the vehicle and leaves the scene.

[REDACTED] began to download the video to a USB drive which he will be dropping off at the [REDACTED] Police Department on November 2nd, 2018. I secured a Supporting Deposition from [REDACTED] and cleared the scene.

I conducted a NCIC check of the vehicles registration. The vehicle was registered to Ms Laura C. Ebert who resides at [REDACTED]. Based off my observation of the security footage, I patrolled to the residence and made contact with Ms Ebert and she was subsequently taken into custody for petit larceny. Ms Ebert stated that she was "sorry" and that she had disposed of the signs. Ms Ebert was then transported to the [REDACTED] Police Department for processing. Ms Ebert was read her Miranda Warnings but did not provide further information, nor if she committed other larcenies of signs in the area. Ms Ebert was processed, released and is scheduled to appear in the [REDACTED] Court on November 13th, 2018 at 5pm.

I provided Ms Ebert a courtesy transport to her residence. While providing the transport, Ms Ebert showed me the location of the disposed signs. Ms Ebert stated she disposed of the signs in the area of [REDACTED]. I completed the transport and returned to the area and recovered both signs.

Signs were placed into the evidence repository.
