MAEC facilitates this process by reviewing the cultural, structural, and material dimensions necessary for making transformational change. We provide technical assistance, professional learning, and tools necessary to operationalize equity into practice.

MAEC's family engagement project focuses on high impact culturally responsive family engagement by building partnerships among schools, parents, and community organizations to improve the development and academic achievement of all students. By increasing opportunities for a shared responsibility between schools and families, there is a greater likelihood of student success and well-being.

MAEC's youth leadership development projects focus on increased graduation rates, academics, enrichment, character education, college/career readiness, STEM, and mentorship. These after-school programs enable youth to work collaboratively with families, school staff, and community leaders to increase academic achievement and address challenges they face in their daily lives. Youth participate in project-based learning, mentorship opportunities, and civic engagement to provide a platform for their concerns and highlight solutions within the communities they reside.
