These Second Articles of Amendment of Certificate of Limited Partnership of **MLK Village Tower, L.P.** (the "Amendment"), are being filed pursuant to Section 14-9-202 of the Georgia Revised Uniform Limited Partnership Act.

I.

The name of the limited partnership is "**MLK Village Tower, L.P.**" (hereinafter, the "Partnership").

II.

The Certificate of Limited Partnership of the Partnership was filed with the Secretary of State of the State of Georgia (the "Secretary of State") on February 24, 2005 and amended by those Articles of Amendment of Certificate of Limited Partnership of the Partnership filed with the Secretary of State on April 26, 2005 (as amended, the "Certificate").

III.

The Certificate of Limited Partnership of the Partnership is hereby amended by deleting Article II, Registered Agent and Office, of said Certificate of Limited Partnership in its entirety and substituting in lieu thereof the following new Article II:

**"ARTICLE II
REGISTERED AGENT AND OFFICE**

The address of the registered office of the Limited Partnership is 40 Technology Parkway South, #300, Norcross, Gwinnett County, Georgia 30092, and the registered agent of the Limited Partnership is Corporation Service Company, whose address for service of process is the same as that of the registered office."

IV.

The Certificate of the Partnership is further amended by identifying Columbia at MLK Village Tower Partners, LLC as an additional General Partner.

V.

This Amendment shall be effective upon the filing of same with the Secretary of State of the State of Georgia.
