ON 03-04-05 AT APPROXIMATELY 2336 HOURS, WHILE ON UNIFORMED PATROL RIDING OUR BIKES ON A SPECIAL ASSIGNMENT, MYSELF, OFFICER LUJAN, OFFICER VALDEZ AND OFFICER MISQUEZ WERE RIDING IN THE AREA WHEN WE WERE ADVISED OF A LOUD PARTY. WHILE WE WERE RIDING TO THE AREA, THERE WERE SEVERAL VEHICLES LEAVING AND THE PARTY APPEARED TO BE LARGE IN SIZE.

THE FIRST VEHICLE I CAME IN CONTACT HAD THREE MALE SUBJECTS SITTING IN IT. IMMEDIATELY IT LOOKED LIKE THEY WERE TRYING TO HIDE SOMETHING. I TOLD THEM TO NOT MOVE ANYMORE AND TO KEEP THEIR HANDS WHERE THEY WERE. YOU COULD SEE IN PLAIN VIEW THAT THEY HAD A BOTTLE OF TEN HIGH WHICH HAD ITS CONTENTS REMOVED AND ALSO A KEYSTONE BEER CAN NEXT TO THE OTHER SUBJECT IN THE BACK.

AS I MADE CONTACT WITH THE PASSENGER ON ONE SIDE, WHO WAS NICHOLAS OWEN, HE WAS HIGHLY INTOXICATED. I ASKED HIM HOW OLD HE WAS. HE STATED THAT HE WAS 20. ALL SUBJECTS, THE OTHER SUBJECTS IDENTIFIED AS JORDAN DUNHAM AND GABRIEL VASQUEZ, ADVISED THAT THEY WERE 20 AND UNDER 21. HOWEVER, WHEN THEY OPENED THE DOOR, I DETECTED AN ODOR OF MARIJUANA COMING FROM THE VEHICLE. I ASKED THE SUBJECTS IF THERE WAS ANY ILLEGAL DRUGS IN THE VEHICLE THAT I NEEDED TO KNOW ABOUT, THAT I COULD SMELL IT, PLUS THE FACT THAT THEY WERE ALSO CONSUMING ALCOHOLIC BEVERAGES IN PUBLIC AND MINORS IN POSSESSION OF ALCOHOL. MR. VASQUEZ STEPPED FORWARD AND STATED TO ME THAT HE HAD A LITTLE BAGGIE OF MARIJUANA IN HIS POCKET. HE HANDED IT TO ME. I DID A PATDOWN WHERE I LOCATED A MULTICOLORED GLASS PIPE USED FOR SMOKING ILLEGAL NARCOTICS IN HIS POSSESSION. HE ALSO HANDED THAT TO ME. I ASKED JORDAN DUNHAM HOW MUCH HE HAD TO DRINK. HE ADMITTED TO HAVING CONSUMED SEVERAL ALCOHOLIC BEVERAGES AND ALSO HAD AN OPEN BOTTLE OF TEN HIGH WHICH WAS ALSO CONSUMED IN HIS POSSESSION. THE OTHER SUBJECT, NICHOLAS OWEN, ALSO ADMITTED TO CONSUMING SOME ALCOHOLIC BEVERAGES, MICKEY'S 40-OUNCE, AND ALSO HAD AN OPEN CONTAINER OF TEN HIGH NEAR HIM AND A CAN OF KEYSTONE ALSO IN HIS POSSESSION.

ALL SUBJECTS WERE CRIMINALLY CITED. MR. VASQUEZ WAS CRIMINALLY CITED FOR POSSESSION OF MARIJUANA AND POSSESSION OF PARAPHERNALIA. THE OTHER TWO WERE CRIMINALLY CITED FOR MINORS IN POSSESSION OF ALCOHOL.
