ON 11-1-05 AT APPROXIMATELY 2310 HOURS, I WAS DISPATCHED TO 1441 ALAMO, NUMBER B IN REFERENCE TO A LOUD MUSIC COMPLAINT.

I ARRIVED AT THE LOCATION AT APPROXIMATELY 2316 HOURS. OFFICER TODD FROATS (L218) AND OFFICER DEAN THATCHER (L646) WERE ALSO PRESENT. OFFICER THATCHER KNOCKED ON THE FRONT DOOR OF THE RESIDENCE AND I OBSERVED A MALE LATER IDENTIFIED AS GABRIEL VASQUEZ CUTTING A GREEN LEAFY SUBSTANCE IN THE LIVING ROOM. MR. VASQUEZ THEN OPENED THE FRONT DOOR. OFFICER THATCHER ASKED MR. VASQUEZ TO OPEN THE SECURITY DOOR, AND MR. VASQUEZ STATED, "I HAVE SOMETHING TO DO FIRST," AND THEN SHUT THE DOOR.

OFFICER THATCHER THEN OPENED THE DOOR AFTER OFFICER FROATS. I PROCEEDED TO THE WEST BEDROOM AND CONTACTED MR. VASQUEZ. I OBSERVED GREEN LEAFY SUBSTANCE ON A CLEAR PLATE IN THE RESTROOM.

I THEN WROTE TWO CRIMINAL CITATIONS FOR MARIJUANA UNDER ONE OUNCE AND FOR DRUG PARAPHERNALIA TO MR. VASQUEZ.

ON 11-01-05 AT APPROXIMATELY 2340 HOURS, OFFICERS WERE BEING DISPATCHED TO 1441 S. ALAMO, APARTMENT-B, IN REFERENCE TO A NOISE DISTURBANCE CALL ADVISING THAT THERE WAS LOUD MUSIC.

I WAS THE FIRST TO ARRIVE ON SCENE AT THAT LOCATION AND OBSERVED THAT THERE WAS IN FACT MUSIC COMING FROM APARTMENT-B AND I COULD HEAR IT FROM THE SIDEWALK AS WELL AS FROM THE EAST SIDE OF THE APARTMENT IN THE ALLEYWAY.

I KNOCKED ON THE FRONT WINDOW AS WELL AS THE FRONT DOOR, GOT NO RESPONSE. I THEN WENT AROUND TO THE EAST SIDE WHICH WAS IN THE ALLEYWAY AND KNOCKED ON THE BACK DOOR AND ALSO GOT NO RESPONSE. AS I CAME BACK AROUND THE SOUTH SIDE FROM THE EAST SIDE, OFFICER THATCHER AND OFFICER COBURN WERE THERE AND ADVISED THAT THERE WAS A MALE SUBJECT SEATED ON THE COUCH SPLITTING MARIJUANA. UPON LOOKING FROM THE SIDEWALK THROUGH THE WINDOW I ALSO OBSERVED THAT INDIVIDUAL SPLITTING MARIJUANA AND ALSO HAD TWO BLUNT CIGARS ON THE TABLE BESIDE HIM.

WE KNOCKED ON THE DOOR ONCE AGAIN AND THE SUBJECT ASKED WHO IT WAS AND OPENED THE INTERIOR DOOR. HE THEN LOOKED OUT AND OBSERVED THAT IT WAS IN FACT THE POLICE AND WE ASKED HIM TO OPEN THE DOOR AND STEP OUT. HE ADVISED THAT HE "NEEDED TO TAKE CARE OF SOMETHING" AND REFUSED TO OPEN THE DOOR AND STEP OUT. HE THEN SLAMMED THE FRONT DOOR SHUT AND THROUGH THE OPENING IN HIS BLINDS WE COULD OBSERVE THAT HE WENT AND PICKED UP THE MARIJUANA WHICH WAS ON A GLASS PLATE AND PROCEEDED TO GO TO THE WEST SIDE OF THE RESIDENCE INSIDE WITH THE MARIJUANA. BELIEVING THAT HE WAS GOING TO DESTROY THE EVIDENCE AND THE NARCOTICS, WE PULLED THE FRONT SECURITY DOOR OPEN AND FOUND HIM IN THE BATHROOM GETTING READY TO FLUSH THE MARIJUANA. HE WAS TAKEN TO THE FLOOR AND PLACED IN HANDCUFFS AND WALKED BACK OUT TO THE LIVING ROOM AS WE RECOVERED THE MARIJUANA ON THE BATHROOM SINK.

OFFICER COBURN ISSUED HIM CRIMINAL CITATIONS FOR THE POSSESSION OF MARIJUANA AND DRUG PARAPHERNALIA WHICH WAS A GLASS PIPE. THE INDIVIDUAL SIGNED AND RECEIVED HIS COPIES OF THE CRIMINAL CITATIONS.
