## **L679 - Gomez, Julian; CASE Narrative**

**ON 04-28-07 AT APPROXIMATELY 0414 HOURS, WHILE ON UNIFORM PATROL IN THE CITY OF LAS CRUCES, I RESPONDED TO 726 ATHENIAN WAY IN REFERENCE TO A POSSIBLE DOMESTIC. UPON ARRIVAL, I MADE CONTACT WITH A MALE SUBJECT BY THE NAME OF GABRIEL VASQUEZ AND TWO OTHER SUBJECTS. I ASKED WHAT WAS GOING ON AND GABRIEL STATED THAT HE HAD GOTTEN IN AN ARGUMENT WITH HIS GIRLFRIEND. I PULLED HIM ASIDE AND ASKED HIM WHERE HIS GIRLFRIEND WAS. HE STATED THAT SHE HAD ALREADY LEFT AND THAT THEY HAD JUST GOTTEN INTO A VERBAL ARGUMENT. I ASKED IF IT HAD GOTTEN PHYSICAL AT ANY TIME AND HE STATED NO, THAT IT WAS ALL VERBAL.**

**GABRIEL STATED THAT HIS GIRLFRIEND CAME OVER TO HIS HOUSE TO DRINK WITH SOME FRIENDS THAT HE HAD OVER. HE ASKED HER NOT TO DRINK SO MUCH BECAUSE SHE JUST TURNED 21 AND SHE GETS KIND OF WILD WHEN SHE DRINKS. AFTER AWHILE, HE NOTICED THAT SHE KEPT DRINKING AND AFTER HAVING A FEW TOO MANY SHE BEGAN GETTING A LITTLE WILD AND DANCING AROUND IN FRONT OF HIS FRIENDS AND STUFF AT WHICH TIME HE ASKED HER TO PLEASE STOP. SHE GOT UPSET BECAUSE HE HAD TOLD HER WHAT TO DO AND THAT'S WHEN THEY BEGAN ARGUING AND SHE STARTED YELLING AT HIM. HE STATED THAT IT WAS JUST A VERBAL ARGUMENT AND THAT A FRIEND CAME DOWN TO PICK HER UP AND TOOK HER HOME.**

**I ADVISED GABRIEL THAT WE WOULD BE DOING A REPORT AND INFORMED HIM SINCE HE HAD BEEN DRINKING ALSO JUST TO CALL IT A NIGHT AND HE COULD CONTACT HER IN THE MORNING AND THEY COULD TALK ABOUT THEIR ISSUES THEN SO THAT WAY THERE WOULDN'T BE ANY ARGUING OR FIGHTING GOING ON FOR THE REST OF THE NIGHT. I ADVISED FOR THEM TO GO BACK INSIDE THE HOUSE BECAUSE THE OTHER TWO SUBJECTS WERE BEING KIND OF LOUD SO THAT WAY WE WOULDN'T GET ANY COMPLAINTS OF ANYBODY BEING LOUD IN THE AREA.**

**ON APRIL 28, 2007 AT 0414 HOURS WHILE ON DUTY IN UNIFORM PATROLLING IN A MARKED UNIT IN THE CITY OF LAS CRUCES, COUNTY OF DONA ANA, STATE OF NEW MEXICO, OFFICER JULIAN GOMEZ (L679) AND I COMPLETED A CALL AT MEMORIAL MEDICAL CENTER WHEN CENTRAL DISPATCH WAS DISPATCHING OFFICERS TO A POSSIBLE DOMESTIC DISTURBANCE AT 726 HELLENIC NEAR APARTMENT O.**

**OFFICER GOMEZ AND I ADVISED DISPATCH OPERATOR TO CANCEL THE OTHER OFFICERS THAT WOULD BE EN ROUTE FROM OUR LOCATION.**

**OFFICER GOMEZ AND I ARRIVED ON SCENE AT 0417 HOURS. AS WE APPROACHED THE AREA OF APARTMENT O, WE DID HEAR SOME VOICES OF SEVERAL INDIVIDUALS WHO WERE STANDING IN THE STREET IN FRONT OF THAT LOCATION. (REFER TO OFFICER GOMEZ'S PRIMARY INCIDENT REPORT REGARDING HIS INTERVIEW WITH A MALE SUBJECT.)**

**I MADE CONTACT WITH TWO OTHER INDIVIDUALS WHO WERE WITH OFFICER GOMEZ'S PERSON, LATER IDENTIFIED AS ELIZABETH SEELY AND ANGEL SANCHEZ.**

**WHEN I ASKED HER WHAT WAS GOING ON, THEY STATED THAT HER FRIEND'S GIRLFRIEND HAD BEEN DRINKING A LITTLE BIT TOO MUCH AND HE TRIED TO STOP HER FROM DRINKING, AT WHICH POINT SHE BECAME BELLIGERANT AND LEFT. I ASKED HER IF SHE DROVE HERSELF AND THEY TOLD ME THAT NO, THAT SHE WAS ABLE TO GET A DESIGNATED DRIVER AND LEFT.**

**MS. SEELY ALSO MENTIONED THAT SHE HAD JUST TURNED 21 AND THAT SHE WAS DRINKING A LITTLE TOO MUCH AND SHE WAS ALSO GETTING INTO ARGUMENTS WITH OTHER PEOPLE AT THE PARTY. I ASKED HER WHERE THE PARTY WAS AND MS. SEELY AND HER FRIEND, ANGEL SANCHEZ, INDICATED THAT THE PARTY WAS JUST UP THE STREET.**
