PUBLIC NARRATIVE

On Wednesday 10 July 2024 at approximately 0832 hours, the undersigned officer received a radio run to respond for a Fight at the location of 890 23rd Street NW, Washington DC (PSA 207).

V-1 reported to the undersigned officer that he was on his way to work as usual by the park area next to George Washington University Hospital. V-1 also stated that he knows the surrounding area is highly homeless individuals and mental health consumers. As V-1 was walking out the park area, S-1 came around and started punching V-1 multiple times on his face without saying any words. S-1 continued to assault V-1 as they both went down on the ground.

V-1 also reported that after was he was punched 5-6 times on his face, S-1 started saying, "You are not the real Jewish and you guys are murderer, you guys kill people in Gaza and in America." S-1 continued to say racial stuffs to V-1. V-1 believes S-1 referred V-1 as Jewish because he was wearing his yamaka on his head. SPO from George Washington University Hospital arrived on scene and detained S-1

Once MPD arrived on scene, S-1 was stopped and detained by the undersigned officers at the location of 890 23rd Street NW, WDC inside the park area.

V-1 positively identified S-1 as the person who punched him multiple times on his face and started saying racial slur.

Ambulance 23 arrived on scene.

V-1 sustained minor injuries to his face and minor laceration to his right elbow. V-1 was treated on scene and refused to transport to the hospital. V-1 advised he will go to the urgent care on his own.

S-1 also sustained minor laceration to his right knee. S-1 also refused further medical assistance.

S-1 was placed under arrest for Simple Assault and Hate Bias Crime.

S-1 was transported to the Second District for processing by the MPD undersigned officer.
