**A BILL**

To require the Director of National Intelligence to issue a report on interference by Islamic Republic of Iran in United States domestic politics, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Unmasking Networks  
5 of Virtual Election Interference and Lies Act of 2024”.

1 **SEC. 2. REPORT ON INTERFERENCE BY ISLAMIC REPUBLIC**  
2 **OF IRAN IN UNITED STATES DOMESTIC POLI-**  
3 **TICS.**

4 (a) **REPORT REQUIRED.**—Not later than 30 days  
5 after the date of the enactment of this Act, the Director  
6 of National Intelligence shall submit to the congressional  
7 intelligence committees (as defined in section 3 of the Na-  
8 tional Security Act of 1947 (50 U.S.C. 3003)) a report  
9 detailing the interference by the Islamic Republic of Iran  
10 in United States domestic politics that occurred during the  
11 period beginning on October 7, 2023, and ending on the  
12 date of the enactment of this Act.

13 (b) **CONTENTS.**—The report submitted pursuant to  
14 subsection (a) that include the following:

15 (1) A list of the social media accounts being  
16 run by the Islamic Republic.

17 (2) A description of United States protestors to  
18 whom the Islamic Republic has provided financial  
19 support.

20 (3) A list of the protests in the United States  
21 organized by the Islamic Republic.

22 (4) A description of any Iran-led e-mail cam-  
23 paigns targeted at officials of the Federal Govern-  
24 ment, the government of a State, or United States  
25 voters.

1           (5) Such additional information about the inter-  
2           ference described in subsection (a) as the Director  
3           finds relevant.

4           (6) A description of which entities within the  
5           government of the Islamic Republic of Iran are in-  
6           volved in the actions described in paragraphs (1)  
7           through (5).

8           (c) FORM.—The report submitted pursuant to sub-  
9           section (a) shall be submitted in unclassified form, but  
10          may include a classified annex.

11          (d) PUBLIC AVAILABILITY.—The Director shall make  
12          available to the public on a website of the Office of the  
13          Director of National Intelligence the unclassified portion  
14          of the report submitted pursuant to subsection (a).
