COUNT 1

CRIMINAL DAMAGE

On or between October 1, 2018 and October 29, 2018, **DAVID CLARE LOHR**, recklessly defaced or damaged property, to-wit: various food items, of the Safeway store located 926 East Broadway Road in Tempe, Arizona, the Walgreens store located at 1745 East Southern Avenue in Tempe, Arizona, the Target store located at 9000 East Talking Stick Way in Scottsdale, Arizona, the Target store located at 1625 East Camelback, Arizona, the Walgreens located at 6404 South McClintock Drive in Tempe, Arizona, the Target store located at 3425 West Frye Road in Chandler, Arizona, and/or the Target located at 4734 East Ray Road in Phoenix, Arizona, causing damage in an amount of \$2,000.00 or more but less than \$10,000.00, in violation of A.R.S. §§13-1602, 13-1605, 13-1601, 13-701, 13-702, and 13-801.

On or about October 6, 2018, **DAVID CLARE LOHR**, with intent to harm another human being, knowingly introduced, added or mingled poison, bacterium, virus or a chemical compound with any water, food, drink, medicine or other product to be taken by a human being or applied to the body, in violation of A.R.S. §§13-3704, 13-701, 13-702, and 13-801.

COUNT 5

On or about October 12, 2018, **DAVID CLARE LOHR**, with intent to harm another human being, knowingly introduced, added or mingled poison, bacterium, virus or a chemical compound with any water, food, drink, medicine or other product to be taken by a human being or applied to the body, in violation of A.R.S. §§13-3704, 13-701, 13-702, and 13-801.

COUNT 6

On or about October 13, 2018, **DAVID CLARE LOHR**, with intent to harm another human being, knowingly introduced, added or mingled poison, bacterium, virus or a chemical compound with any water, food, drink, medicine or other product to be taken by a human being or applied to the body, in violation of A.R.S. §§13-3704, 13-701, 13-702, and 13-801.

COUNT 7

**ADDING POISON OR OTHER HARMFUL SUBSTANCE TO FOOD, DRINK,

On or about October 14, 2018, **DAVID CLARE LOHR**, with intent to harm another human being, knowingly introduced, added or mingled poison, bacterium, virus or a chemical compound with any water, food, drink, medicine or other product to be taken by a human being or applied to the body, in violation of A.R.S. §§13-3704, 13-701, 13-702, and 13-801.

COUNT 8

On or about October 19, 2018, **DAVID CLARE LOHR**, with intent to harm another human being, knowingly introduced, added or mingled poison, bacterium, virus or a chemical compound with any water, food, drink, medicine or other product to be taken by a human being or applied to the body, in violation of A.R.S. §§13-3704, 13-701, 13-702, and 13-801.

COUNT 9

**ADDING POISON OR OTHER HARMFUL SUBSTANCE TO FOOD, DRINK,
OR MEDICINE**


On or about October 26, 2018, **DAVID CLARE LOHR**, with intent to harm another human being, knowingly introduced, added or mingled poison, bacterium, virus or a chemical compound with any water, food, drink, medicine or other product to be taken by a human being or applied to the body, in violation of A.R.S. §§13-3704, 13-701, 13-702, and 13-801.

COUNT 10

**ADDING POISON OR OTHER HARMFUL SUBSTANCE TO FOOD, DRINK,
OR MEDICINE**


On or about October 29, 2018, **DAVID CLARE LOHR**, with intent to harm another human being, knowingly introduced, added or mingled poison, bacterium, virus or a chemical compound with any water, food, drink, medicine or other product to be taken by a human being or applied to the body, in violation of A.R.S. §§13-3704, 13-701, 13-702, and 13-801.

Pursuant to A.R.S. § 21-425, the State Grand Jurors find that the offenses described above were committed in Maricopa County, Arizona.


