On 8/30/2015, Officer McLamb # 5178 was working the desk position at Wilkens Precinct when [REDACTED] (13 years old, DOB 10/5/2001) and his mother [REDACTED] walked in to report that [REDACTED] was sexually assaulted by a known adult, Matthew David Lucas (35 years old, DOB 7/18/1980). [REDACTED] advised that this incident occurred while Lucas was temporarily responsible for [REDACTED] supervision.

[REDACTED] reported that on 8/29/2015, he and Suspect Lucas performed various sexual acts on each other at the suspect's grandparent's house located at 4420 Linden Ave Halethorpe, Baltimore County, Maryland.

Detective Carns #4558 of the Baltimore County Police Crimes Against Children Unit was notified of this incident. Detective Carns directed Officer McLamb to escort [REDACTED] and Ms. Brown to the CAC office for [REDACTED] to be interviewed.

Upon their arrival, Detective Carns interviewed [REDACTED] and learned that [REDACTED], Suspect Lucas and [REDACTED] Aunt, Jennifer Hoffman, spent the evening of 8/29/2015 at the Ravens football game in Baltimore. Suspect Lucas drove [REDACTED] and Ms. Hoffman home after the game, dropping Ms. Hoffman off first. Then, Suspect Lucas told [REDACTED] that he needed to check on his grandparent's house on Linden Ave because the burglar alarm was going off. This left [REDACTED] alone with an in the care of Suspect Lucas. [REDACTED] asked to be dropped off first, but Suspect Lucas insisted that [REDACTED] come with him to check on the house.

When they arrived at 4420 Linden Ave. [REDACTED] stated that he wanted to stay in the car, but Suspect Lucas again insisted that [REDACTED] come into the house. [REDACTED] noted that when they got into the house, Suspect Lucas turned the alarm off and that there didn't seem to any alarms going off.

Suspect Lucas went upstairs to use the bathroom, and [REDACTED] sat down on the couch. When Suspect Lucas came back down, he sat next to [REDACTED] and told him to take his pants off. [REDACTED] stated that he was afraid, due to previous sexual abuse, and that he felt like he couldn't run away, so he complied with the suspect's directions and removed his pants. Suspect Lucas then removed his pants as well and began to masturbate [REDACTED] penis. Suspect Lucas also took [REDACTED] hand and placed it on his penis, making [REDACTED] masturbate the suspect's penis.

[REDACTED] described Suspect Lucas producing a pink, gel, masturbation device and a black bottle containing lubricant from a black computer bag that he pulled out of the trunk of his red Scion (Maryland registration 7BG2739) before they went into the house. The bottle of lubricant bore the words "premium" and "lube" on it.

They used this masturbation device on each other and [REDACTED] described them moving from the couch onto the floor. [REDACTED] explained that Suspect Lucas ejaculated on the carpet next to the coffee table.

[REDACTED] next described Suspect Lucas performing fellatio on him and trying to penetrate the victim's anus with his finger at the same time. [REDACTED] stated that he was unsure if the suspect's finger actually penetrated into his rectum, but he felt the pressure of the suspect's fingers on his anus.

Suspect Lucas' teeth (which are false teeth) caused an injury to [REDACTED] penis while the suspect was performing fellatio on [REDACTED]. [REDACTED] stated that this cut was bleeding, but the bleeding later stopped. Eventually, [REDACTED] stated "I give up" because he was unable to ejaculate and Suspect Lucas stopped performing fellatio. They then got dressed and Suspect Lucas drove him home.

[REDACTED] described Suspect Lucas wearing blue cargo shorts, a black tank top and tight "speedo" style underwear of an unknown color.

[REDACTED] also described Suspect Lucas showing him pictures of penises on his cell phone, a Samsung Note (with a phone number of 443-542-1677). [REDACTED] explained that Suspect Lucas was looking at these pictures in full view of [REDACTED] and that he specifically pointed out pictures of his own penis to [REDACTED]. [REDACTED] recognized the suspect's penis due to the suspect previously exposing himself to [REDACTED] in Ocean City, Maryland in June of 2015.

Based on [REDACTED] disclosure, Detective Carns sought and obtained a search and seizure warrant for the address of 4420 Linden Ave, 21227 and for Suspect Lucas' red Scion. The Honorable Judge Wilson of the District Court of Maryland for Baltimore County reviewed and signed the search warrant on 8/30/2015 at 11:30 AM.

The search warrant was executed at 4420 Linden Ave on 8/30/2015 at 12:00 PM. Crime Lab Technician Officer Yi #3891 responded and photographed and processed the house. Utilizing a "Crime-Lite," Officer Yi was able to locate three distinct areas on the carpet close to the coffee table that appeared to contain biological material. These areas of the carpet were cut out and seized as evidence. When Officer Yi placed the pieces of carpet in evidence envelopes, two of the pieces were still so saturated with biological matter that the paper envelopes soaked through and had to be placed in a second evidence envelope to double-layer the packaging.

Suspect Lucas was not at 4420 Linden Ave at the time of the search warrant execution, so Detective Carns called his cell phone (443-542-1677) and left a message for him to call back. Suspect Lucas called back a few minutes later and at Detective Carns' request, he responded to 4420 Linden Ave. Upon his arrival, he was operating his red Scion. Detective Carns explained that he had a search warrant for his grandparent's house, his car and his cell phone. Suspect Lucas handed his phone to Detective Carns, who then ensured that it was not pass code protected and placed it in "airplane" mode to prevent the phone from communicating with cellular or Wi-Fi signals.

Detective Carns read Suspect Lucas his rights per Miranda, read him the search warrant and asked him if he would be willing to come back to the CAC office to be interviewed. He was told at that time that he was not under arrest. Suspect Lucas agreed and he was transported by Detective Carns from 4420 Linden Ave to the CAC office.

Suspect Lucas was placed in the monitored interview room by Detective Carns. Suspect Lucas read his rights per Miranda, initialed next to each line, signed the form and advised that he understood his rights and still agreed to be interviewed.

In the course of this recorded interview, Suspect Lucas confessed that he and [REDACTED] masturbated each other's penises and performed oral sex on each other. Suspect Lucas further confirmed that he ejaculated in the area that [REDACTED] described, the same area where the carpet was found to contain biological matter.

Cursory visual examination of the cell phone revealed numerous photographs of male genitalia as [REDACTED] described.

All events occurred in Baltimore County.
