THE INFORMATION BELOW IS CONFIDENTIAL - FOR USE BY AUTHORIZED PERSONNEL ONLY

DURING A VERY LARGE PROTEST IN FRONT OF MCDONALDS, THE ARRESTED SUBJECTS WERE IN THE STREET BLOCKING SOUTHBOUND VEHICULAR TRAFFIC, THE Q - LINE RAIL CAR, AND THE DRIVEWAY OF THE MCDONALDS. SUBJECTS ALSO HAD A TABLE AND CHAIRS SET UP IN THE STREET. SUBJECTS WERE ADVISED SEVERAL TIMES TO MOVE OUT OF THE STREET BY POLICE OFFICES BUT REFUSED TO DO SO.

SUBJECTS WERE ARRESTED WITHOUT INCIDENT FOR DISORDERLY CONDUCT, AND CONVEYED TO THE DDC IN THE PRISONER BUS. ALL WERE ISSUED ORD`S AND RELEASED FROM THE DDC (NOT FINGER PRINTED)
